The Request for Bids (RFB) will be conducted through the International Competitive Bidding process as specified in the [Inter-American Development Bank's Procurement Policies for the Procurement of Goods and Works](#) (applicable edition according to the Loan Contract) and is open to all bidders from eligible countries, as defined in the Bidding Documents.
 5. The qualification requirements include

Qualification requirements are listed below: A margin of preference for certain goods manufactured domestically shall not be applied. Additional details are provided in the Bidding Documents.

(a) *If the Bidder is a manufacturer:*

(i) Financial Capability

The Bidder shall furnish documentary evidence that it meets the following financial requirement(s):

a. Bank reference to show it is a good customer, and conducts loans and credits facilities to the full satisfaction of the bank;

*b. availability of at least **BZ\$500,000.00** in cash or in bank credit facilities;*

(ii) Experience and Technical Capacity

The Bidder shall furnish documentary evidence to demonstrate that it meets the following experience requirement(s):

- A minimum of one (1) contracts of similar scope, nature, type and of value to the offered goods executed in the last three (3) years supported by a reference letter*

(b) *If Bidder is not a manufacturer:*

If a Bidder is not a manufacturer, but is offering the Goods on behalf of the Manufacturer under Manufacturer's Authorization Form (Section V, Bidding Forms), the Bidder shall demonstrate the above qualifications (i), and (ii).

A Margin of Preference for national contractors or joint ventures will not be granted. Further details are provided in the Bidding Document. In this process, the Best and Final Offer (B.A.F.O.) will be applied.
