1. This invitation for Bids (IFB) is issued following the publication of the General Procurement Notice (GPN) for this project, which was published on the Inter-American Development Bank's website under publication number 1175095 on 04 April 2023.
2. Suriname has received financing from the Inter-American Development Bank (IDB) to partially finance the cost of the Water Supply Modernization Program and intends to apply part of the proceeds to payments under the Contract detailed in this Request for Bids.
3. The Surinaamsche Waterleiding Maatschapij invites eligible bidders to submit sealed bids for Purchase of Pipes Fittings and Accessories destined for DMA Flora.
4. The Request for Bids (RFB) will be conducted through the National Competitive Bidding process as specified in the [Inter-American Development Bank's Procurement Policies for the Procurement of Goods and Works](#) (applicable edition according to the Loan Contract) and is open to all bidders from eligible countries, as defined in the Bidding Documents.
5. The qualification requirements include
 1. **Letter of Bid** prepared in accordance with ITB 12;
 2. **Price Schedules:** completed in accordance with ITB 12 and ITB 14;
 3. **Bid-Securing Declaration**, in accordance with ITB 19.2;
 4. **Authorization:** written confirmation authorizing the signatory of the Bid to commit the Bidder, in accordance with ITB 20.3. Proof of the authorized signatory must be delivered

through a valid document, such as an extract from the Chamber of Commerce, or any other document applicable in the Bidder's country.

5. **Qualifications:** documentary evidence in accordance with ITB 17 establishing the Bidder's qualifications to perform the Contract if its Bid is accepted;
6. **Bidder's Eligibility:** documentary evidence in accordance with ITB 17 establishing the Bidder's eligibility to bid;
7. **Eligibility of Goods and Related Services:** documentary evidence in accordance with ITB 16, establishing the eligibility of the Goods and Related Services to be supplied by the Bidder;
8. **Conformity:** documentary evidence in accordance with ITB 16 and 30, that the Goods and Related Services conform to the bidding document; and
9. any other document required in the **BDS**.

A Margin of Preference for national contractors or joint ventures will be granted. Further details are provided in the Bidding Document.
